**Discussion**

Larry distributed information from the Supervisor Guide pertaining to County Road Commission obligations for roads, along with communications from the township attorney.

CCRC will match \$39,734 for road contracts for 2023.

CCRC submitted the following estimates for roads for 2023:

CCRC has made a request to the State of Michigan to take over Dewey Lake Street as a county/district road. They are still waiting on a response.

Discussion about taking approximately \$100,000 from general fund to use for road projects for the upcoming budget.

CCRC has submitted for a single dust control application for all dirt roads in the township. The townships responsibility would be \$24,183.20. Annette has been in touch with SWMDC who has submitted a private quote to the sitting board members.

Suggestions have been made to Bob to look into having Special Assessments done for the lake roads.

The Parker estimate does not have the correct description, and Bob will be requested a new one.
